## Senior Masters Tournament Rules

1. Only Genesee Region USBC Association members (Men & Women) carrying an average of at least 21 games during 2020-21 season or at least 12 games during the current 2021-22 season are eligible. All bowlers must be USBC certified for the current 2021-22 season. Entrants may require proof of their USBC individual membership card.
2. A bowler must be 50 years old as of November 20, 2021 to meet the minimum age requirement.
3. One Re-Entry is allowed, but an individual can cash only once.
4. Entries close on Saturday, November 20 at 3:00 PM.
5. Maximum of 24 bowlers on all qualifying squads.
6. A tie for 12<sup>th</sup> place during the qualifying round will be settled by a one game roll-off.
7. Any ties that need to be broken during the final round will be settled by a 9<sup>th</sup> and 10<sup>th</sup> frame roll-off.
8. All prizes will be paid in cash and prizes will be 100% returned and 1 out of 4 entries will cash.
9. All other USBC rules are in effect.
10. All COVID-19 guidelines such as face coverings and social distancing will be in effect.
