## TOURNAMENT RULES:

1. All Genesee Region USBC Youth members are eligible to enter and must be USBC members in 2024-25.
2. Entries will be accepted on a first-come, first-served basis.
3. Paid entries: Doubles -- \$20 per bowler/\$40 per team. Teams -- \$20 per bowler/\$60 per team
4. **ENTRY FEES MUST ACCOMPANY THE ENTRY FORM. INCOMPLETE ENTRIES WILL BE VOIDED.**
5. Teams will consist boys, girls or mixed.
6. **Doubles:** Bowlers will compete in one of the following divisions: **Division A** – combined bowler average of 250 and over **Division B** – combined bowler averages of 249 and under, with individual handicap based on 90 percent of 200 as outlined in rule number 7.  
  
**Teams:** Competition will take place in one division – individual handicap based on 90 percent of 200 as outlined in rule number 7.
7. Individual handicap will be 90% of 200 for all divisions.
8. Substitutes will be allowed. No changes in line-up will be allowed except for substitutes. No vacancy scores will be allowed.
9. All bowlers are responsible for the accuracy of their average. Failure to notify a tournament official of the proper average prior to the completion of the first game shall disqualify the bowler.
10. Highest individual USBC current average for the 2024-25 season will be used for handicap (12 games minimum). For the Team tournament, Travel League averages that are higher than house league averages must be used. Please bring proof of average on the day of the event.
11. If a bowler does not have a current year USBC average, bowler will use highest 2023-24 USBC average (minimum 12 games).
12. If a bowler does not have a current year or 2023-24 USBC average, then the bowler will bowl scratch.
13. All bowlers are asked to report at least **30 minutes before** starting time.
14. All USBC rules will be observed.
15. Award fees returned 100% through scholarships and awards.
16. Team and doubles events, there must be at least one bowler change in lineup to re-enter in the same division and the required average limits need to be met.
17. The decision of the Tournament Director will be final in resolving all disputes or dealing with any unforeseen situations or emergencies, unless an appeal is made in accordance with USBC Rule #329.
18. Trophies will be awarded for the first 3 spots in each division. First place teams in each division in doubles and team events will win \$100 scholarships.
19. **No alcoholic beverages are allowed near the bowlers during the tournament. All alcoholic beverages must stay in the bar area.**
